MAKE PLANS FOR ST. PATRICK'S DAY PARADE



St. Patrick's Day Parade Saturday, March 14, 2020 Balboa Park, San Diego

"In the past, it has been warm so make sure your top priority is to keep the dogs comfortable"



We will all meet at the Alcazar Gardens parking lot between 8 and 8:30 am and have coffee and donuts available. This will also give us plenty of time to exercise the dogs and ready them for the parade. The parking lot fills up early, so plan accordingly. Please remember "pick-up" bags and also a water bottle or bucket for the dogs. (Weather can be unpredictable – hot, cold, rainy or in-between!) If the weather appears it is going to be warm, you can freeze cubes or cakes beforehand to carry in a small bucket. The water will stay cool longer and not spill.

Directions:

Take I-5 or 163 south to Park Avenue exit. Go north to Presidents Way, turn left in the park to the stop sign. Turn right, and go all the way past the Organ Pavilion to the end of the street. Go around the traffic circle, back towards the way you came, and make the first right into Alcazar Gardens parking lot.

The color of the day is "GREEN", so plan your dog's ensemble (and yours!) accordingly. This is a fun day to spend with other club members and their Irish. Everyone is Irish on St. Patrick's Day !!

In the past, it has gotten quite warm and the top priority is to make sure the dogs are comfortable. Please bring a 6-foot leather lead for your dog; <u>do NOT bring a flexi/retractable lead</u>. Our dogs need to be on their best behavior and under control at all times. This can be a very long walk for our red senior citizens, so be aware of their needs during the parade.

We'll leave the parking area by 8:55 to walk to the staging area. The officials like us to be in place by 9:30 am, because step off is 10:30 am.
